**A RESOLUTION AUTHORIZING APPLICATION FOR FISCAL
SPONSORSHIP WITH THE WYOMING BUSINESS COUNCIL
UNDER THE BUSINESS READY COMMUNITY GRANT AND
LOAN PROGRAM FOR A COMMUNITY READINESS PROJECT
ON BEHALF OF THE GOVERNING BODY OF THE TOWN OF
BAR NUNN, WYOMING**

FOR THE PURPOSE OF:

Construction of a Community Recreation Center/Multi-purpose Facility which will provide essential services to the Town of Bar Nunn and which would also serve as a place to provide recreational activities and services for the growing community of Bar Nunn.

WITNESSETH

WHEREAS, the Governing Body of the Town of Bar Nunn, Wyoming desires to participate in the Wyoming Business Council under the Business Ready Community Grant and Loan Program for a Community Readiness Project to assist in financing this project; and

WHEREAS, the Governing Body of the Town of Bar Nunn, Wyoming recognizes the need for the construction of a Town Hall to house the municipal offices for the Town of Bar Nunn, and which will also include recreational facilities for the residents of the community, and believes this project will address those needs; and

WHEREAS, the public benefit(s) of this project will be updated administrative and governmental space for the administration of the government of the Town of Bar Nunn, which has outgrown its current facilities, combined with the provision of recreational space for the residents of the community which is lacking in the same and the consideration is; and

WHEREAS, the specific goals and measures of success of this project are Community Recreation Center/Multi-purpose Facility which will provide essential services to the Town of Bar Nunn and which would also serve as a place to provide recreational activities and services for the growing community of Bar Nunn; and

WHEREAS, the Wyoming Business Council under the Business Ready Community Grant and Loan Program requires that certain criteria be met, as described in the Wyoming Business Council's Rules governing the program, and to the best of our knowledge this application meets those criteria; and

WHEREAS, the Governing Body of the Town of Bar Nunn, Wyoming, plans to provide cash match to this Wyoming Business Council under the Business Ready Community Grant and Loan Program Community Readiness project from the following source(s):

Town of Bar Nunn General Fund in the amount of \$3.4 million dollars
and

WHEREAS, the Governing Body of the Town of Bar Nunn, Wyoming to provide in-kind match to this Wyoming Business Council under the Business Ready Community Grant and Loan Program Community Readiness project from the following source(s):

Town of Bar Nunn General Fund.

and

WHEREAS, the Governing Body for the Town of Bar Nunn, Wyoming has a comprehensive operation and maintenance plan including projected expenses and project income sources extending the life of the asset; and

WHEREAS, the Governing Body for the Town of Bar Nunn, Wyoming will use the revenue recaptured from this project for the following economic development purposes: To maintain operations and maintenance of community center; and

WHEREAS, In the event of any project cost overruns, the Town of Bar Nunn, Wyoming will provide funding in the amount necessary to complete the project utilizing Town of Bar Nunn General Fund and Ear Marked Funds for Community Recreation Center and other Grants; and

WHEREAS, the Governing Body for the Town of Bar Nunn, Wyoming has considered other possible funding solutions for this project which include participation in the Federal Mineral Royalty Capital Construction Account Grant; and

NOW, THEREFORE, BE IT RESOLVED BY THE GOVERNING BODY OF THE Town of Bar Nunn, that a grant application in the amount of \$500,000.00 be submitted to the Wyoming Business Council for consideration of assistance in funding the Community Recreation Center as set out above.

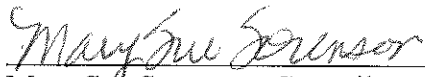

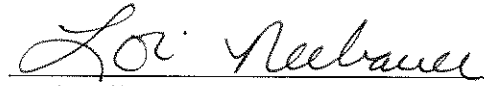
